

ORDINANCE NO. 02-2014

CITY OF DIAMOND CITY, BOONE COUNTY, ARKANSAS

**AN ORDINANCE CREATING THE DIAMOND CITY
COMMUNITY CENTER BOARD AND PRESCRIBING OTHER
MATTERS RELATED THERETO.**

WHEREAS, Diamond City owns and operates real property and a building that is used as a community center for the benefit of the citizens of Diamond City; and

WHEREAS, the City Council has decided that it is in the best interests of the citizens of Diamond City that a Community Center Board be established to work towards the better improvement, operation and maintenance of the Diamond City Community Center,

NOW THEREFORE, BE IT ENACTED, by the City Council of the City of Diamond City, as follows:

Section 1. Creation. There is hereby created a Board of the City of Diamond City, Arkansas, to be known as the “Diamond City Community Center Board” which shall be comprised of five (5) members.

Section 2. Powers and Duties. The Board shall have all of the powers and duties delegated to it by the Diamond City City Council. The Community Center Board may establish a separate bank account for the transaction of business. The Community Center Board will have the power to take all steps and proceedings and to enter into all contracts and agreements necessary or incidental to the performance of its duties, except any contract relating to financing or any trust indenture shall be approved by the Diamond City City Council before it is effective. The Board may employ personnel and volunteers as may be necessary in the execution of its powers and duties, and may fix their compensation. All compensation, expenses and liabilities shall be paid solely from funds provided to the Diamond City Community Center by the Council or through rent of the premises or fund raising activities conducted by the Board. The Board may not bind the municipality beyond this amount.

The Board shall:

- (a) operate, manage and control the Community Center and may order and complete any extensions, betterment’s and improvements if funds are available or are made available;
- (b) establish rules and regulations for the use and operation of the Community Center and the library housed therein; and
- (c) do all things necessary and expedient for the successful operating of the Community Center.

Section 3. Members. The members of the Board shall be appointed and sworn in by the Mayor of Diamond City and shall become valid following confirmation of such appointments by the City Council. The terms of service for a member of the Board shall be unrestricted. The initial membership of the Board, as nominated and approved hereunder shall be as follows:

Section 4. Bylaws: The bylaws attached to this ordinance may be amended as necessary by the Diamond City Community Center Board. A copy of the amendment shall be attached to the original ordinance.

Section 5. Severability. In the event that any section, paragraph, subdivision, clause, phrase, or other provision or portion of this Ordinance shall be adjudged invalid or unconstitutional, the same shall not affect the validity of this Ordinance as a whole, or any part or provision, other than the part so decided to be invalid or unconstitutional, and the remaining provisions of this Ordinance shall be construed as if such invalid, unenforceable or unconstitutional provision or provisions had never been contained herein.

Section 6. Repeal of Conflicting Ordinances. Any matters set forth in this Ordinance which are contrary to the existing ordinances of the City of Diamond City shall prevail, and all other ordinances and resolutions or parts of ordinances and resolutions in conflict herewith and therewith are hereby repealed to the extent of such conflict.


