

ORDINANCE NO. 2010-03 - 10

CITY OF DIAMOND, BOONE COUNTY, ARKANSAS

AN ORDINANCE DESIGNATING PLACES FOR THE POSTING OF ORDINANCES; DECLARING AN EMERGENCY; AND PRESCRIBING OTHER MATTERS RELATED THERETO.

WHEREAS, no newspaper is published within the corporate municipal limits of the City of Diamond, Arkansas (the "Municipality"); and

WHEREAS, it is appropriate, pursuant to Act No. 295 of the Acts of Arkansas of 1993, that the Municipality designate five of the most public places in the Municipality for posting of notice of the adoption of ordinances of the Municipality;

NOW THEREFORE, BE IT ENACTED, by the City Council of the City of Diamond, as follows:

Section 1. Designation of Public Places. The following places, which are hereby found to be five of the most public places in the Municipality, are hereby designated for the posting of notice of the adoption of ordinances of the Municipality:

Section 2. Notice by Posting. Notice of the adoption of ordinances of the Municipality shall be effected by the posting of ordinances at the locations set forth in Section 1 hereof and any other site deemed necessary.

Section 3. Repeal of Conflicting Ordinances and Resolutions. All ordinances and resolutions and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

Section 4. Declaration of Emergency. It has been found that proper notification of the adoption of Ordinances of the City of Diamond is essential to the governance of the City of Diamond. Therefore, an emergency is declared and this Ordinance, being necessary for preservation of the public peace, health and safety, shall be in force upon its passage and approval.
