

ORDINANCE NO. 5-11

CITY OF DIAMOND CITY, BOONE COUNTY, ARKANSAS

AN ORDINANCE ESTABLISHING THE DIAMOND CITY COMMUNITY VOLUNTEER CORPS.

**WHEREAS**, Diamond City has an interest in the promotion of meaningful opportunities for civic service and volunteerism to benefit its citizens;

**WHEREAS**, Diamond City provides a variety of opportunities for volunteers to help the City provide quality and caring service to the Diamond City community;

**WHEREAS**, Diamond City desires to make sure that said volunteers shall enjoy the protection of the state's sovereign immunity to the same extent as paid employees of the City as provided in A.C.A § 21-13-108(b); and

**WHEREAS**, it is in the best interests of the citizens of the Diamond City that the Diamond City Community Volunteer Corps is established as provided hereunder.


**NOW, THEREFORE, BE IT ENACTED**, by the City Council of Diamond City, as follows:

1. Section 1. The Diamond City Community Volunteers Corps. is hereby established. The Mayor shall appoint a Chairperson from the community to assist with the coordination of the Community Volunteer Corps. Such appointment is subject to approval by the City Council.
2. Section 2. The Mayor, or the Mayor's representative or designee, on behalf of Diamond City, Arkansas, is hereby authorized to develop volunteer programs and accept the services of volunteers, including regular-service volunteers, occasional-service volunteers, or material donors to assist in programs carried out by the Diamond City Community Volunteers Corps. The Mayor, or the Mayor's representative or designee, is further authorized to develop written rules governing the recruitment, training, screening, responsibility, utilization, supervision of volunteers and other rules, actions and parameters found under A.C.A. 21-13-101 *et seq.*
3. All ordinances or parts thereof in conflict herewith are hereby repealed to the extent of such conflict.
