WHEREAS; AMENDING SECTION 1 OF ORDINANCE 04-2022.

AN ORDINACE BY THE CITY COUNCIL OF DIAMOND CITY, BOONE COUNTY, ARKANSAS FOR AMENDING THE SALARY OF THE DIAMOND CITY RECORDER TEMPORARY POSITION FOR THE 5 MONTH PERIOD FROM JULY 23, 2024 AND ENDING DECEMBER 31, 2024 & THROUGH THE 4-YEAR TERM FOLLOWING THE REGULAR ELECTION OF SAID POSITION ON NOVEMBER 5, 2024, ENDING DECEMBER 31, 2028. THE REMAINING 2024 SALARY APPROPRIATION PRO-RATED DISBURSEMENT OF THE BUDGET ITEM IN PLACE IN THE 2024 BUDGET EXPENDITURES AGREED UPON BY CITY COUNCIL. APPROVAL 01-2024.

SECTION 1 AMENDMENT:
