

CITY OF DIAMOND CITY, BOONE COUNTY, ARKANSAS

ORDINANCE 04-2025 AMENDING 03-2024

AN ORDINANCE BY THE CITY COUNCIL OF DIAMOND CITY, ARKANSAS TO AMEND SECTION VIII - CLAUSE 1; THE WATER RATES ESTABLISHED BY ORDINANCE 03-2024 TO CLARIFY THE RESIDENTIAL BASE WATER, SEWER, AND SENIOR RATE BEING CHARGED TO ALL RESIDENTIAL CUSTOMERS OF THE CITY OF DIAMOND CITY, ARKANSAS WATER SYSTEM AND DECLARING AN EMERGENCY.

SECTION VIII - WATER RATES

1. THE FOLLOWING TABLE WILL BE THE RATES FOR SERVICE FROM THE DIAMOND CITY WATER AND SEWER SYSTEM AND TRASH.

RESIDENTIAL BASE RATE:

WATER \$25.00 FLAT FEE - FIRST 1,000 GALLONS

WATER \$.0135 AFTER 1,000 GALLONS - (WILL BE PRORATED)

SEWER \$29.00 FLAT FEE - FIRST 1,000 GALLONS

SEWER \$.0120 AFTER 1,000 GALLONS - (WILL BE PRORATED)

TRASH \$21.58 FLAT FEE

FSWA \$.40

SENIOR BASE RATE:

WILL BE \$10.00 OFF THE TOTAL BILL NOT TO INCLUDE TAXES.

2. TO ENSURE THE FUTURE SOLVENCY OF THE CITY OF DIAMOND CITY, ARKANSAS, THERE WILL BE A REVIEW OF THE CURRENT WATER, SEWER, AND TRASH RATES TO EVALUATE ANY NEEDED INCREASES IN THE MONTH OF JANUARY OF EACH CALENDAR YEAR BEGINNING WITH THE YEAR 2022. THE DIAMOND CITY COUNCIL WITH THE RECOMMENDATION OF THE MAYOR WILL SET THE RATE INCREASE.

SEVERABILITY; THIS ORDINANCE IS HEREBY DECLARED TO BE SEVERABLE. SHOULD ANY SECTION OR SUBSECTION BE DECLARED BY THE COURTS TO BE UNCONSTITUTIONAL OR INVALID, SAID DECISION SHALL NOT AFFECT THE ORDINANCE AS A WHOLE.

EMERGENCY CLAUSE: IT IS HEREBY FOUND THAT THE ESTABLISHED RATES AND CHANGES FOR THE WATER, SEWER, AND TRASH FOR THE CITY OF DIAMOND CITY AND IT'S CITIZENS ARE CRITICAL FOR THE FAIRNESS AND GROWTH OF THE CITY. THE PROVISION HEREOF HAS IMMEDIATE EFFECT AND THEREFORE THIS ORDINANCE SHALL BE IN FULL EFFECT FROM AND AFTER ITS PASSAGE.

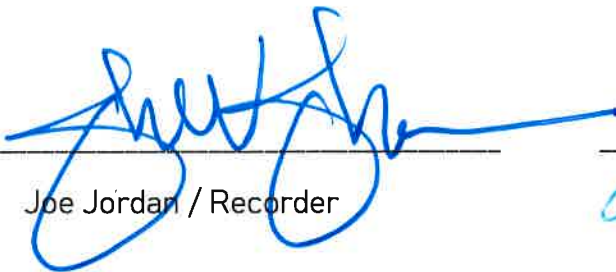

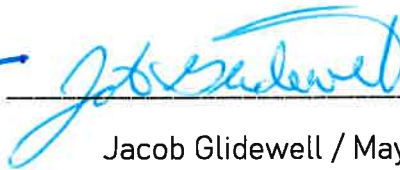
